MINUTES

Town Council Meeting
December 9, 2025

The Town of Blowing Rock Town Council met for their regular monthly meeting on Tuesday, December 9, 2025, at 6:00 p.m. The meeting took place at Town Hall located at 1036 Main Street, Blowing Rock, NC. Present were Mayor Charlie Sellers, Mayor Pro-Tem Doug Matheson, Council Members Cat Perry and David Harwood. Newly Elected Council Members Wayne Miller and Melissa Tausche. Council Members Melissa Pickett and Pete Gherini were unable to attend. Others in attendance were Interim Town Manager Lane Bailey, Town Attorney Joey Petrack, Planning Director Kevin Rothrock, Police Chief Nathan Kirk, Finance Director Tasha Brown, Public Works Director Matt Blackburn, IT Director Thomas Steele, Parks and Recreation Director Jennifer Brown and Town Clerk Hilari Hubner, who recorded the minutes.

CALL TO ORDER

Mayor Sellers called the meeting to order at 6:00 p.m. and welcomed everyone. Mayor Sellers verified attendance via roll call.

THE PLEDGE OF ALLEGIANCE

MINUTE APPROVAL

Mayor Pro-Tem Matheson made the motion to approve the minutes from November 12, 2025, regular session and closed session, seconded by Council Member Harwood. Unanimously approved.

Mayor Sellers asked Interim Town Manager Lane Bailey to move the Special Recognition of Council Members Pickett and Gherini to the January meeting since both were unable to attend.

OATH OF OFFICE

Town Clerk Hilari Hubner administered the Oath of Office to incumbent Mayor Charlie Sellers, incumbent Council Member Doug Matheson and newly elected Council Member Wayne Miller.

Clerk of Superior Court Charles Haynes administered the Oath of Office to newly elected Council Member Melissa Tausche.

Mayor Sellers asked Council if they would agree to move the selection of RTAC Member and TDA Council representative selection to Winter Retreat. Council consensus was to move those selections to Winter Retreat.

- Mayor Pro-Tem Harwood – Welcomed new Council Members Miller and Tausche, thanked outgoing Council Members Pickett and Gherini for their service to the Town, welcomed Interim Town Manager Lane Bailey, thanked Parks and Recreation staff for a great parade, noted he had the pleasure to drive the old fire

Enclosed please find a Budget Amendment Ordinance for the fiscal year 2025-2026 for your consideration.

Section 1 (General Fund) allocates funding as follows:

- Allocates funds (\$806) donated to the Blowing Rock Academy by the Boone Area Chamber of Commerce, High Country Childcare Stabilization Grant. This allocation has been directed towards Materials/Supplies – P&R.

Section 2 (Water/Sewer Fund) allocates funding as follows:

- Allocates fund balance (\$11,000) to cover increased costs for engineering fees for various water/sewer projects. This allocation has been directed towards Engineering Services – W/S Admin.

Section 3 (General Fund) allocates funding as follows:

- Allocates Afterschool fees received over budget (\$10,400) and fund balance (\$31,872) to cover increased costs for staffing and supplies for the afterschool program. This is due to an increase in the number of children attending than expected. This allocation also covers the increased cost of the department's utilities and unforeseen staffing costs for the department. This allocation has been directed towards various lines for the P&R department as listed on page 2.

Be it ordained by the Town Council of the Town of Blowing Rock, North Carolina, that the following amendment be made to the annual budget ordinance for the fiscal year ending June 30, 2026:

Section 1. To amend the General Fund, the appropriations are to be changed as follows:
